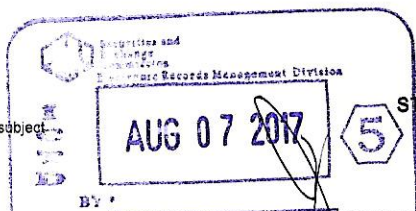

**Item 1. Security and Issuer**

**Item 2. Identity and Background**


