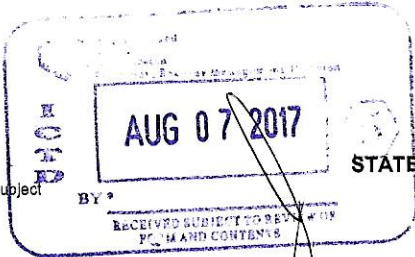

**Item 1. Security and Issuer**
